

SWEEPSTAKES OFFICIAL RULES

NO PURCHASE, PAYMENT OR OBLIGATION OF ANY KIND IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES.

Agreement. These rules govern Citizens Bank & Trust's Sweepstakes ("Giveaway"). No purchase is necessary to enter the Giveaway. The act of entering the constitutes as acceptance of the Giveaway rules and the decisions of the Sponsor, which decisions should be final and binding on all entrants.

Sponsor. The Giveaway sponsor is Citizens Bank & Trust, a division of Lineage Bank, 1359 E Main St, Atwood, TN 38220 ("Sponsor").

Eligibility. The Giveaway is open to legal residents of the United States who are 18 years of age or older as of the date of entry. Void elsewhere and where prohibited by law. Employees, Officers and Directors of the Sponsor, as well as members of their immediate family and household are not eligible for participation. Business entities are also not eligible. Period. The Giveaway period begins December 15th, 2022, and ends at 2 pm CT on December 22nd, 2022 (such period, the "Giveaway Period").

Entry. There two ways to participate: (1) By completing the instructions on the Citizens Bank & Trust Facebook Post prior to 10 am CT of the date of the event December 22nd, 2022, or (2) By completing an entry form the day of the event. Limit of 1 entry per person. A purchase does not increase your chances of winning. Entries must be processed by entry deadline to qualify. Odds of winning depend on the number of eligible entries received.

Winner Selection. The winner(s) will be selected at the date of the event by random drawing. Winner may be contacted by mail, phone, in-person or private social media message on or within 5 business days from the date of the event. If Sponsor is unable to receive personal confirmation from a winner of being selected as a Winner within three days from the first notification attempt, or if a Winner (i) is found to be ineligible, or (ii) fails to comply with the Official Rules, the Prize will be forfeited, and an alternate potential winner may be selected from among all remaining eligible entries. The winner must visit Atwood Branch to collect the prize. Sponsor will not mail or courier the prize.
